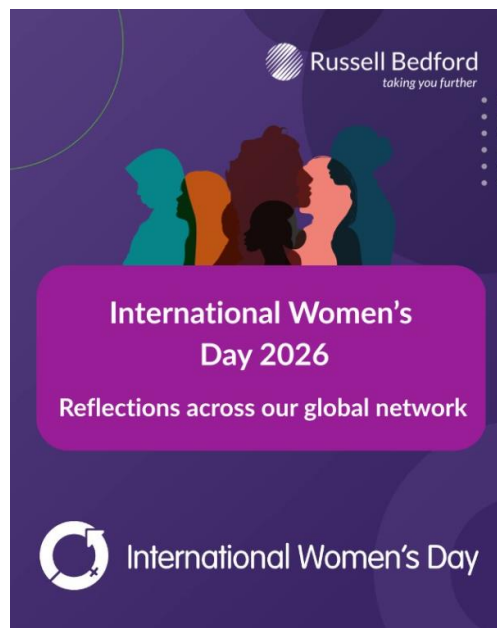

## IPPC Group in India wins 'Excellence in Consultancy Services'

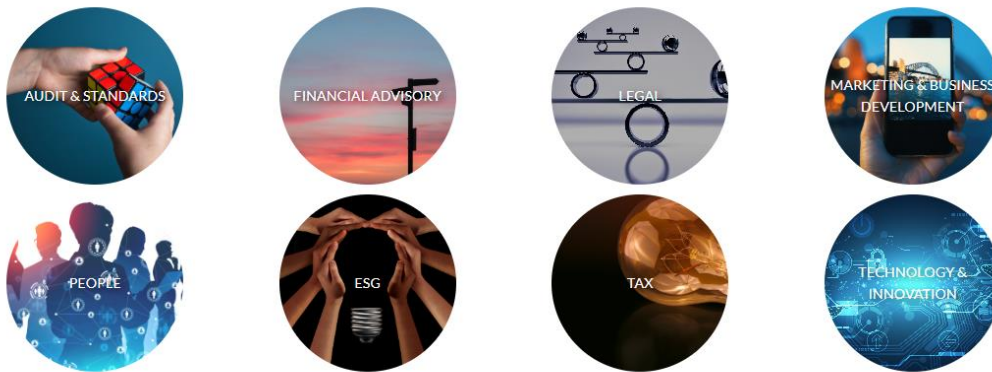
